1. A local law to repeal and replace Chapter 162, "Noise," establishing standards for unreasonable noise, prohibited conduct, exceptions, and enforcement.
2. A local law to repeal and replace Article I of Chapter 168, "Lighting Nuisances," regulating light trespass, glare, and related outdoor-lighting nuisances.
3. A local law to repeal and replace Article I of Chapter 184, "Brush, Grass, and Weeds," regulating excessive growth and providing for notice, removal, cost recovery, and penalties.
4. A local law to repeal and replace Article III of Chapter 184, "Use of Trucks, Trailers, and Shipping Containers for Storage," regulating such use and establishing a shipping-container permit.
5. A local law to repeal and replace Chapter 238, "Trailers," regulating the storage and occupancy of house trailers and the licensing of house trailer camps.
6. A local law to repeal and replace Chapter 249, "Vehicles, Off-Road," regulating the operation of motorcycles, limited-use motorcycles, and off-road vehicles.
7. A local law to enact a new Chapter 103, "Domestic Animals and Livestock," regulating the non-commercial keeping of livestock, poultry, and rabbits.
