RESOLUTION #68-2026 OF THE TOWN BOARD, TOWN OF NEWFANE, NY

RESOLUTION CALLING FOR A PUBLIC HEARING UPON A PROPOSED RESOLUTION ESTABLISHING A SCHEDULE OF SEWER RENTS FOR THE TOWN OF NEWFANE TOWNWIDE SEWER DISTRICT

WHEREAS, the Town of Newfane owns, operates, and maintains a sanitary sewer collection, pumping, treatment, and disposal system on behalf of the Town of Newfane Townwide Sewer District, which district is governed by the Town Board of the Town of Newfane; and

WHEREAS, § 452 of the General Municipal Law authorizes a town, on behalf of a sewer district, to establish and impose sewer rents by resolution, and provides that a resolution establishing and imposing sewer rents shall be adopted only after a public hearing upon five days' public notice; and

WHEREAS, by Local Law adopted by this Town Board on September 10, 2026, Article XI of Chapter 196 of the Code of the Town of Newfane was repealed and replaced, and § 196-11.3D of the Code as so amended provides that the dollar amount of each sewer rent shall be established, and may from time to time be amended, by resolution of the Town Board adopted after a public hearing, notice of which shall be published in the official newspaper of the Town not less than five days before the date of the hearing; and

WHEREAS, there has been presented to this Town Board a proposed resolution establishing a Schedule of Sewer Rents for the Townwide Sewer District in accordance with said Local Law;

NOW, THEREFORE, BE IT RESOLVED, that a public hearing shall be held before the Town Board of the Town of Newfane on September 23, 2026, at 6:45 p.m., at the Town Hall, 2737 Main Street, Newfane, New York, upon the proposed resolution establishing a Schedule of Sewer Rents for the Town of Newfane Townwide Sewer District, at which hearing all parties of interest and citizens will be heard; and

BE IT FURTHER RESOLVED, that the Town Clerk is hereby directed to cause notice of said public hearing to be published once in the official newspaper of the Town of Newfane not less than five days before the date of said hearing, and to cause the same to be posted on the Town signboard and on the Town's website; and

BE IT FURTHER RESOLVED, that a copy of the proposed resolution shall be kept on file in the office of the Town Clerk and shall be available for public inspection during regular business hours from the date of publication of said notice through the date of said public hearing.
