RESOLUTION #44-2025

TOWN OF NEWFANE ACCEPTANCE OF THE DRAFT AMENDMENT TO THE LOCAL WATERFRONT REVITALIZATION PROGRAM (LWRP) FOR SUBMISSION TO NEW YORK STATE

WHEREAS, the Town of Newfane originally adopted a Local Waterfront Revitalization Program (LWRP) on March 26, 1997, and has recently undertaken the preparation of an amendment to that 1997 update in cooperation and coordination with the New York State Department of State, and in accordance with the provisions of Article 42 of the New York State Executive Law; and

WHEREAS, the Draft Amendment to the LWRP has been prepared under the review and guidance of the Town of Newfane Waterfront Advisory Committee, with consultant planning services provided by Wendel; and

WHEREAS, the Newfane Town Board, as lead agency, prepared an Environmental Assessment Form to identify and evaluate the potential impacts of adopting the amended LWRP, in accordance with the requirements of the State Environmental Quality Review Act (SEQRA) and Part 617 of the implementing regulations of Article 8 of the New York State Environmental Conservation Law; and

WHEREAS, the Newfane Town Board has determined that this action will not result in any anticipated adverse impacts to the natural, institutional, economic, developmental, or social resources of the Town, and prepared and adopted a SEQR Negative Declaration in this regard; and

WHEREAS, the Newfane Town Board held a public hearing on November 25th, 2025, to gather additional public questions and comments on the Draft Amendment to the LWRP and, in evaluation of this input, has determined that the Draft Amendment to the LWRP is complete and ready for required review by all appropriate public agencies,

THEREFORE BE IT RESOLVED, that the Draft Amendment to the Local Waterfront Revitalization Program for the Town of Newfane is accepted by the Town Board as complete and ready for public agency review, and shall be submitted to the New York State Department of State for distribution to and subsequent review by Federal, State, and regional agencies pursuant to the provisions of Article 42 of the New York State Executive Law.
